

AMERANT BANK PANTHERS VIP SUITE TICKET SWEEPSTAKES OFFICIAL RULES

1. Eligibility

The Amerant Bank Panthers VIP Suite Ticket Sweepstakes (the “Sweepstakes”) is open to individuals who submit an entry through the official Sweepstakes form available at www.amerantbank.com/florida-panthers-sweepstakes. Entrants (“You”) must be **18 years of age or older** at the time of entry.

This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is **void where prohibited**.

Employees of Amerant Bank, N.A. (“Sponsor”), its subsidiaries, affiliates, partners, advertising and promotion agencies, and their immediate family members or those living in the same household are **not eligible** to participate.

2. Sponsorship

The Sweepstakes is sponsored by **Amerant Bank, N.A.**, located at 220 Alhambra Circle, Coral Gables, FL 33134.

3. Agreement to Rules

By entering, You agree to be fully and unconditionally bound by these Official Rules and the Sponsor’s decisions, which are final and binding. Sponsor may refuse, disqualify, or withdraw any entry at its sole discretion. You represent that You meet all eligibility requirements.

4. Sweepstakes Entry Period

The Sweepstakes entry period begins on **March 13th at 12:00 AM ET** and ends on **March 14th at 11:59 PM ET** (“Entry Period”). Entries received outside this period will not be considered.

5. How to Enter

Eligible entrants may enter by completing and submitting the online entry form at www.amerantbank.com/florida-panthers-sweepstakes during the Entry Period. Incomplete entries or entries that do not comply with these Rules may be disqualified at Sponsor’s sole discretion. Limit one entry per person unless otherwise stated.

6. Prize

One (1) winner (the “Winner”) will receive:

- **Four (4) tickets** to a Florida Panthers game in the **Amerant Bank VIP Suite** at Amerant Bank Arena.

Travel, transportation, parking, lodging, meals, and any other expenses related to attending the game are NOT included.

The specific game date will be determined by Sponsor and communicated to the Winner. The prize is non-transferable, non-refundable, and may not be substituted for cash or any other prize except at Sponsor's sole discretion.

The Winner is responsible for all applicable federal, state, and local taxes.

By accepting the prize, the Winner grants Sponsor permission to use their name, likeness, and entry for promotional purposes without additional compensation unless prohibited by law.

7. Odds

Odds of winning depend on the total number of eligible entries received.

8. Winner Selection & Notification

One Winner will be selected in a **random drawing** conducted by Sponsor after the close of the Entry Period.

The Winner will be notified by **email and/or phone** within 30 days of selection. Sponsor is not responsible for notifications that are blocked, filtered, incorrect, or otherwise undeliverable.

If the Winner fails to respond within **30 days**, is deemed ineligible, or does not complete required documentation, the prize may be forfeited and an alternate Winner selected.

9. Rights Granted by You

By entering, You grant Sponsor and its authorized representatives the right, where permitted by law, to use your name, image, entry submission, and statements for promotional and advertising purposes in any media without further notice or compensation.

10. Terms & Conditions

Sponsor reserves the right to modify, suspend, or terminate the Sweepstakes if fraud, technical issues, or other factors impact its integrity or proper functioning.

Any attempt to tamper with the entry process or the Sweepstakes website may result in disqualification and potential legal action.

11. Limitation of Liability

By entering, You agree to release and hold harmless Sponsor and its affiliates, employees, agents, and representatives from any claims, damages, losses, or liabilities arising from

participation in the Sweepstakes or acceptance and use of the prize, including but not limited to:

1. technical malfunctions,
2. unauthorized human intervention,
3. errors in administration or entry processing,
4. travel or event-related incidents.

12. Disputes

This Sweepstakes is governed by Florida law. Any disputes arising from or relating to the Sweepstakes shall be resolved individually, without class action, exclusively in a court of competent jurisdiction located in Florida.

Entrants waive the right to claim punitive, incidental, or consequential damages.
